Staff Report

It is an interesting time and continues to be so. In the past two weeks, we have trespassed three people from the properties. One is repeat offender of the mask issue, but they are belligerent and pick fights with Staff. The Police have a sub station across the street from the Eastside store now in the old liquor control building, so response time was immediate. The next day, at the Westside store, we had to issue a no trespass order to someone living in the lot across the alley. The third person trespassed, came to a Eastside register and displayed a knife in a sheath and grabbed his stuff and walked out the door without paying. We later realized they were camping in the bike shed. We issued a trespass notice, instead of them being arrested and charged. The tensions are building and continue to build. That same day we had another incident in which a customer collapsed in the Produce aisle. We are trying to open a conversation with Disability advocates in the desire of treating people with dignity. We hung in there with them close to an hour after they initially refused medical attention. It became clear they would not be able to walk back home in their condition. The Medics transported them. The good thing is we aren't fighting with each other. Most of days, we leave the store exhausted.

Jayana was East when the first incident happened and thought the Staff responded very well. The Police were there very quickly and handled the situation very well.

Fern spoke about the Westside person, who has scared away long time customers over the course of the year. Staff are backing each other up about safety in the Staff parking lot at night and after hours. Mel has heard the same feedback from customers and thinks it is important that we make a statement.

There was a shopper at the Eastside that filled an entire cart up, overflowing and then left. We restocked the cart and we called the City Emergency Response Team, but they didn't get there in time. We checked in with them and we learned a lot about how to give information to individuals. We will be using that service in the future as well. We are approaching the one year mark for one of the groups that was hired. Two of them, in two Departments were recommended for Collective membership. We have lots of hours available so everyone was able to get their commitments done. We think we did a pretty decent job with the Zoom trainings. It has been a very smooth process. We will have a second hire group coming up to Collective membership.

Bathrooms West are closed to the general public and a port o potty has been installed in the bike shed. It has been really great to have less traffic in the Warehouse.

We are an open carry state and there are a number of Staff people that are uncomfortable with people being armed in the Stores. There are two or three staff people that are serious about talking about how to make it a no weapons space. Grace feels that that decision should engage the Board. Its simple to see it from the black and white, personally she is more comfortable with an open carry than a concealed carry. Grace also wonders about our way to enforce it. It should be a decision to be made between Staff and Board.

Joanne - What about no open carry with alcohol? No, that is applicable only where it is served not where it is sold.

Cris - How does Staff feel?

Staff has not discussed it as a whole. This is a building discussion. She guesses that most Staff would feel more comfortable with no weapons in the store.

Jim has one concern of putting Staff in the position of enforcing this policy with someone who is armed .

Jayana feels that it is going to be a bit more complicated then us making a decision and wants to make it clear that it won't be that straight forward.

Grocery Store workers are finally included in Phase one vaccinations. Grace has her appointment this Saturday.

Feedback:

Jayana asked about morale. She can't imagine working in that environment and recognizes that is tough.

Grace responded that the assessment of morale is it ebbs and flows. Some issues have to do with how individuals react to stressful situations. Once the situation is settled we checkin with each other regularly. We are good at validating with each other how hard it is and how different it is in these times. Jim spoke to when he was volunteering staff are amazing at checking in with each other and volunteers.

Member Appeals Process Update

Linda is coming back to the Board with the documents that the Board approved last month with a clarification made by the Member Relations Committee at their recent meeting.

The Board consented to the process and asked for the word ' discovery' to be changed to ' decision'. The Committee declined this change. Discovery is the process of finding the information and not the decision.

Feedback:

Mel read that document today and does not remember the last line to be worded like it is.

Fred asked what was the old flavor, believes that the wording Mel remembers is part of the process document and not the form.

Jim suggested new wording.

Mel feels that someone needs to be the final word and its not clear.
